however, when the contractors read the red book, they will find that the book is not for their project. they will also find that the book does not cover all types of projects. for example, the red book covers some types of repairs such as painting the house. also, the red book covers the most common types of the projects, which are listed as follows:

design - the contractor may have been involved in the design. it is a project that uses the red book. budget - the contractor may have participated in the budgeting process. rendering - the contractor may have had to prepare the project by way of rendering. site visit - the contractor may have had to conduct a site visit. commissioning - the contractor may have had to commission the project.

testing - the contractor may have been involved in the testing of the project. with the introduction of the red book, the project value for any type of project that uses fidic contracts would be determined using the estimated quantities of the items of plant as per the red book. the red book projects are typically development projects for the construction of a new hospital, new commercial complex or new building on a site such as a factory or a manufacturing facility. in addition, the projects may be refurbishment projects on existing buildings. however, it must be noted that the red book does not cover all types of projects, and not all fidic projects are covered by the red book. the red book was revised in 1987, and the changes were primarily in the quantities clauses and the extension of time clause. the red book has now become a standard of contract practice in the construction industry. the standard of contract practice is very important because it is a way of establishing a point of consistency in the industry and giving contractors a basis of common practice for contracts. hence, the red

book is a widely used resource in the industry.

the red book 2017 is an international standard fidic contract. if parties are signing a contract with a provision that does not conform to the red book 2017, this may result in disputes and/or litigation. the contractor may decide that the cost of altering the contract is too great in relation to the cost of the delay, or the delay may be deemed to be unforeseeable (such as external forces beyond the parties control). the contractor may decide to alter the terms and conditions of the contract and negotiate with the engineer and the employer to ensure that the contract will be concluded within the time period specified in the contract. this may mean that the contract is not a fidic contract and must be negotiated as a standard contract and the parties are responsible for any terms and conditions that are not provided in the standard fidic contract. for those seeking further information on the new 2017 suite, fidic will issue an update in early 2018. in the meantime, please refer to

the fidic website (www.fidic.org), and the fidic dispute process and/or fidic advocacy sections of the website to discover more. the inclusion of this indemnity is likely to cause contractors problems, particularly considering debates about whether and the extent to which the contractor can assume a fitness for purpose obligation based on recent case law. dispute adjudication / avoidance board (daab)the new clause 21 in the 2017 red book requires the parties jointly to appoint standing daab; that is, a dispute adjudication / avoidance board that is appointed at the start of the contract, which visits the site on a regular basis and remains in place for the duration of the contract to assist the parties in the avoidance of disputes, and in the real time resolution of disputes, if and when they arise. 5ec8ef588b
